All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, near the Bramlett Road, on the south side of Arch Street Extension, being known and designated as Lot No. 20 on plat of property of F. B. Massingale made by J. Coke Smith, May 15th, 1947, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 109, and having the following metes and bounds according to said plat:

BEGINNING at a stake on the south side of Arch Street Extension, at corner of Lot No. 19, and running thence in a southeasterly direction with line of Lot No. 19, 232.3 feet to stake near the Bramlett Road; thence N. 60-25 E. 60 feet to stake at corner of Lot No. 21; thence in a northwesterly direction with line of Lot No. 21, 231.6 feet to stake on the south side of Arch Street Extension; and thence in a westerly direction with the south side of Arch Street Extension 60 feet to the beginning corner.
