to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, W. R. Ellis, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, being known and designated as Lot No. 98, of a subdivision known as Stone Lake Heights, Section No. 2, as shown on plat thereof prepared by Piedmont Engineering Service, July 15, 1953, and recorded in the R. M. C. office for Greenville County in Plat Book W, at page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Lake Forest Drive, the joint front corner of Lots 97 and 98, and running thence along the eastern edge of Lake Forest Drive, following the curvature thereof, the chord of which is N. 0-25 E. 110 feet, to an iron pin, the joint front corner of Lots 98 and 99; thence along the joint line of said lots, S. 87-46 E. 205.7 feet to an iron pin on the rear line of Lot 93; thence along the rear lines of Lots 93 and 94, S. 2-52 W. 110 feet to an iron pin, joint rear corner of Lots 97 and 98; thence along the joint line of said lots, N. 87-39 W 200.8 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. office for Greenville County in Deed Vol. 483, at page 355, and is also subject to certain easements or rights-of-way for the installation and maintenance of public utilities, which easements also appear of record in said R. M. C. office.

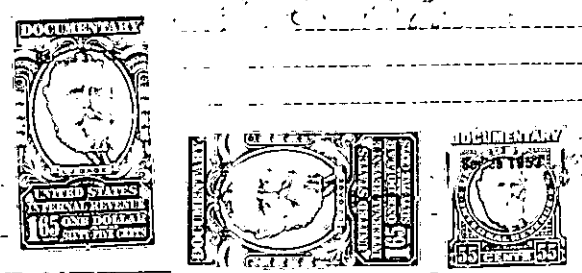
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
