Know All Men by These Presents:

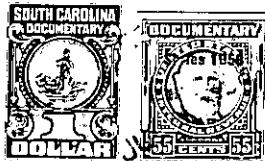
That I, John Shell Ashmore in the State aforesaid,
in consideration of the sum of Five Hundred and no/100 (\$500.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles F. Centt, his heirs and assigns forever.

All that certain piece, parcel or lot of land situate and located in the City of Greenville, Greenville County, South Carolina, on Pine Street, known and designated as lot No. Twenty-Six (26) in a sub-division known as Richoltown Heights No. 2, a plat of which is recorded in the R. L. C. Office for said County and State in Flat Book "L" at page 3, and according to said plat is described as follows:

beginning at an iron pin on Pine Street at the joint front corner of lots Nos. 25 and 26 and running thence with Pine Street, S-34-C-2, 40 feet to joint front corner lot Nos. 26 and 27; thence S-56-C-E, 120 feet to joint rear corner of lots Nos. 26 and 27; thence with joint line of lots Nos. 26 and 27, N-34-C-W, 40 feet to joint rear corner of lots Nos. 26 and 27; thence N-30-C-E, 120 feet to the beginning corner, and being the same lot of land conveyed to the grantor herein by Elvira J. Karscy on May 22, 1953, deed recorded in said R. L. C. Office in deed book 478, Page 528 and being shown on the County Block Book as (319) 201-17-8.

Pine Street is now known as Colorado Street

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
