Know All Men by These Presents:

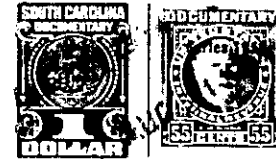
That I, Jeff R. Richardson, as Trustee in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kate Blakely, her heirs and assigns forever

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina in or near the Town of Simpsonville, lying to the east of the C. & W. C. Railroad and being lot No. 39, in a subdivision now known as Forest Park and formerly known as Gresham Park. This being part of the property conveyed to me by William C. Gresham, Sr., and Wilton H. Gresham by deed dated November 6, 1953 and recorded in R. L. C. Office for Greenville County in Deed Book 488, page 267.

The property conveyed is subject to the following restrictions:

1. No building other than residential property shall be constructed on any lot herein conveyed.
2. No dwelling costing less than \$10,000.00 shall be constructed on this property.
3. No livestock such as cattle, horses, hogs, goats or chickens shall be maintained, housed or pastured on this property.
4. Any residence must be constructed at least 35 feet from the street.
