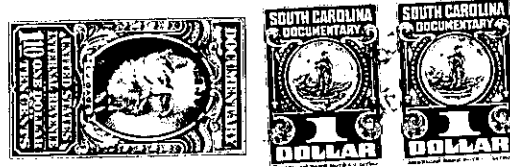

C., in Plat Book "AA", at page 123, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Maco Street at joint front corner of Lots 1 and 2 and running thence with the line of Lot 2, S. 56-27 W. 289.7 feet to an iron pin; thence S. 28-0 E. 75.8 feet to an iron pin; thence along the line of property now or formerly of Whitmire, N. 55-24 E. 300.1 feet to an iron pin on the Southwest side of Maco Street; thence along the Southwest side of Maco Street, N. 36-02 W. 70 feet to the beginning corner.
