All that certain lot of land in the city of Greenville, county of Greenville, state of South Carolina, known and designated as lot No. 55 of the Nicholtown Heights # 2 subdivision, shown on plat made by W. J. Riddle, Surveyor, March 1911, recorded in the R. M. C. Office for Greenville County in plat book M at page 3 to which said plat reference is hereby made for a more complete description. Said lot has a frontage on the southeastern side of River Street of 10 feet and runs back in parallel lines of approximately 190 feet to Steady River.

This is one of the same lots conveyed to grantor by Massalena Bowen by deed dated April 30, 1953 recorded in deed volume 479 page 3.

This lot is subject to right of way given to the Greater Greenville Sewer District Commission recorded in deed volume 429 at page 372, and right of way to Duke Power Company for public utilities.
