to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto STORK BUILDING, INC.:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, in a subdivision known as Medical Court, being known and designated as a portion of Lot No. 6 of said subdivision and being described according to a plat prepared by the Piedmont Engineering Service, Greenville, S. C., dated September, 1949, entitled "Plat of Medical Court, Greenville, S. C.," which plat is of record in the R. M. C. Office for Greenville County, S. C., in Plat Book W at page 77. The property herein conveyed has according to the aforementioned recorded plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at a point in the center of a 20-foot street at its intersection with Arlington Avenue, joint front corner of Lots Nos. 6 and 7, and running thence along the common line of said lots in the center of said 20-foot street N. 18-24 E. 90.6 feet to a point; thence S. 71-27 E. 80 feet to a point; thence S. 18-24 W. 91 feet to an iron pin on the Northern side of Arlington Avenue; thence along the Northern side of Arlington Avenue N. 71-13 W. 80 feet to the beginning corner.

This property is conveyed subject to, and with the benefit of, easements and restrictions established for the mutual benefit of all the property in Medical Court Subdivision, as shown on plat of said subdivision, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book W, at page 77.

The above described property is the identical property conveyed to David F. Watson by deed of Albert J. Quigley and C. V. Latham, dated October 26, 1949, and recorded in the R. M. C. Office for Greenville County in Deed Volume 394 at page 447, less a 12-foot strip on the Northeastern side conveyed by David F. Watson to William R. DeLoache, et al, by deed dated August 4, 1954, and recorded in the R. M. C. Office for Greenville County in Deed Volume 505 at page 307. The undivided one-half interest of the Grantor, Willard C. Hearin, Jr., in the foregoing premises was acquired by deed of David F. Watson dated _____, 1954, and being recorded in the R. M. C. Office for Greenville County.

And the grantor(s) do hereby bind the grantor(s) and the grantor(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s) successors and Assigns against the grantor(s) and grantor(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
