JOHN L. HENDERSON, HIS HEIRS AND ASSIGNS,

ALL that certain piece, parcel or lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 66 and a part of 67 on Plat of Pine Brook Development, made by W. N. Willis, Engr. March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 148, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on Eastern side of Brewster Drive at the joint corner of Lots 63 and 66 and running thence N.56-29 E. 150 feet to an iron pin in rear line of Lot 67 and being the joint rear corner of Lots 63 and 71; thence in a Southeasterly direction, which line divides Lot No.67, 156 feet, more or less, to a point on Northern side of Edwards Road; thence along Northern side of the Edwards Road, S.44-36 W. 153 feet, more or less, to an iron pin at the North Eastern corner of the intersection of Brewster Drive and Edwards Road; thence with Eastern side of Brewster Drive, N.33-31 W. 183 feet to an iron pin, point of beginning.
