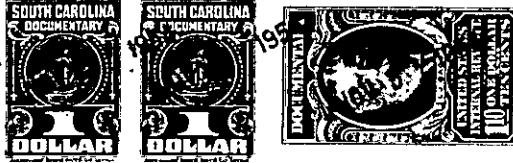

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A. B. Skelton, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the east side of the Augusta Road being Lot No. 77 in a subdivision of Pecan Terrace shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", page 9 and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the east side of the Augusta Road at the southeast corner of said Road and Rocky Knoll Drive and running thence with Rocky Knoll Drive S. 54-27 E. 90 feet to an iron pin; thence still with said Drive S. 38-42 E. 50.2 feet to an iron pin corner of Lot No. 76; thence with the line of that lot S. 64-34 W. 129.2 feet to an iron pin on right-of-way line of Augusta Road; thence with said Road N. 0-09 W. 106.2 feet to an iron pin; thence still with the right-of-way line of Augusta Road N. 16-01 E. 42.3 feet to an iron pin, the beginning corner.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)

The above is part of the property conveyed to the Grantor by E. Inman, Master by deed recorded in the R. M. C. Office for Greenville County in Deed Book 140, page 108.
