That I, Donald E. Baltz OLLIE FARNSWORTH in the State aforesaid, in consideration of the sum of Twelve Thousand Nine Hundred Seventy-five DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Stowe William Hoyle,

All that lot of land in Greenville Township, Greenville County, state of South Carolina, near the incorporate limits of the city of Greenville, being known and designated as lot No. 22, on plat of property of Donald E. Baltz, recorded in plat book Y page 46 of the R. I. C., Office for Greenville County and having according to a recent survey made November 1954 by R. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Sharon Drive the front joint corner of lots Nos. 22 and 23, and running thence with the joint line of said lots N. 32-07 E. 150 feet to an iron pin corner of lot No. 17; thence with the line of said lot S. 57-53 E. 75 feet to an iron pin corner of lot No. 20; thence with the rear line of lots Nos. 20 and 21, S. 32-07 W. 150 feet to an iron pin on northeastern side of Sharon Drive; thence with the northeastern side of said Street N. 57-53 W. 75 feet to the beginning corner.

Being a portion of the property conveyed to Donald E. Baltz by Lucy L. Gifford by deed dated January 31, 1951 recorded in volume 429 page 170 of the R. I. C. Office for Greenville County.

This lot shall be used for residential purposes only, and only one single family residence shall be erected thereon. No trailer, garage or other out-building shall be used for living quarters.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

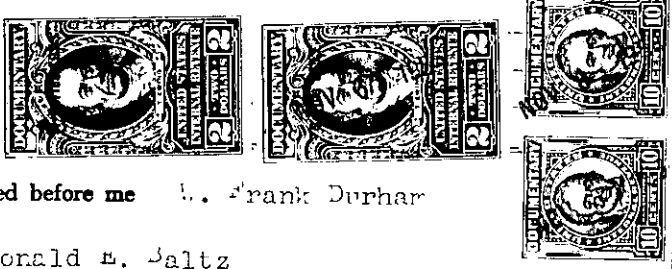
