to the granter(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ward S. Stone, his heirs and assigns forever:

All those three (3) certain pieces, parcels or lots of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the West side of Railroad Street and the East side of Center Street, being shown as all of Lots 18, 50 and 51 on plat of property of Fegan & Mosely, prepared by R. E. Dalton, Eng., in July, 1911; which plat is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book A, at page 145, and according to said plat having (when described together) the following metes and bounds, to-wit:
