all that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, located on the South West side of Dalewood Drive, north of the Town of Simpsonville, being known and designated as lot No. 68, 72 & 73 on a plat of property of D. L. Bramlett, subdivision known as "Dalewood Heights", plat thereof made by C. O. Riddle, Surveyor, in February 1953 and recorded in Plat Book , at page , this said plat being a part of lands as shown on a larger plat of property of Mrs. Rosa J. BEGINNING at an iron pin on the south west side of Dalewood Drive at corner of lot No. 67, and running thence along line of lot No. 67, S. 41-00 W. 248.5 feet to an iron pin on King line; thence along King line S. 51-15 E. 100 feet to iron pin at corner of lot No. 69; thence along line of lot No. 69, N. 41-00 E. 244.5 feet to iron pin on Dalewood Drive; thence along Dalewood Drive, N. 49-00 W. 100 feet to the beginning corner.

Lot No. 72 and 73 -

BEGINNING at an iron pin on the South west side of Dalewood Drive at corner of lot No. 71 and running thence along line of lot No. 71, S. 41-00 W. 232.4 feet to iron pin on King line; thence along King line S. 51-15 E. 200 feet to iron pin at corner of lot No. 74; thence along line of lot No. 74, N. 41-00 E. 224.4 feet to iron pin on Dalewood Drive; thence along Dalewood Drive N. 49-00 W. 200 feet to the beginning corner.
