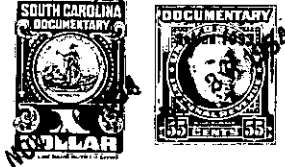
Know All Men by These Presents:

ALL that piece, parcel or lot of land in Chirck Springs Township, Greenville County, State of South Carolina, designated as Lot No. 5 on plat made by J. Mac Richardson, February, 1950, and recorded in the R.M.C. Office for Greenville County in Plat Book at page, and according to said plat having the following metes and bounds, to wit:
