All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Northwesterly side of Chipley Lane, near the City of Greenville, S. C., being shown as Lot No. 93 on the plat of Chestnut Hills as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, pages 34-35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Chipley Lane at a point 480 feet southwest of the Westerly corner of the intersection of Chipley Lane and Simpson Street, said pin being the joint front corner of Lots Nos. 92 and 93, and running thence along the Northwesterly side of Chipley Lane S 28-13 W 65 feet to an iron pin, joint front corner of Lots Nos. 93 and 94; thence along the joint line of said Lots N 63-41 W 150 feet to an iron pin; thence N 28-13 E 70 feet to an iron pin, joint rear corner of Lots Nos. 92 and 93; thence along the joint line of said Lots S 61-47 E 150 feet to the point of beginning.
