to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ROLAND RANDALL SKELTON, his heirs and assigns, forever:

ALL that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the Southwest side of North Estate Drive near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 49 on Plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", page 189, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest side of North Estate Drive at joint front corner of Lots 49 and 50 and running thence with the line of Lot 50, S. 47-00 W., 120.7 feet to an iron pin; thence with the line of Lot 51, S. 36-15 E., 106.1 feet to an iron pin; thence along line of property now or formerly of Martha S. Scott, N. 54-45 E., 90 feet to an iron pin on the Southwest side of North Estate Drive; thence with North Estate Drive, N. 16-35 W., 62.5 feet to an iron pin; thence continuing along the North Estate Drive, N. 28-50 W., 62.5 feet to the beginning corner.
