Richerson (receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FRANK A. RICHERSON AND LILLIE M. RICHERSON, their heirs and assigns, forever, the following described lands:

"All that lot of land on Parker Road in Greenville County, South Carolina, being a portion of Lots Nos. 300, 301, 302, 303 and 304 as shown on a plat of property of Colonia Company recorded in Plat Book "J", at page 190, in the R.M.C. Office for Greenville County and being all of the property situate South of Langston Creek between Parker and Franklin Roads, being bounded on the North by property of F.
