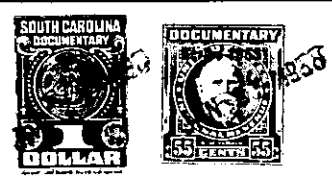

Know All Men by These Presents:

That We, W. H. Poole and Annie Poole, in the State aforesaid, in consideration of the sum of Four Hundred and No/100 (\$400.00) - - - - -DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina State Highway Department, its successors and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 20 of property of P. L. Bruce, according to a plat of said subdivision recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book W, at page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of an unnamed street, joint front corner of Lots Nos. 19 and 20, and running thence N. 34-55 E. 60 feet to an iron pin, joint front corner of Lots Nos. 20 and 21; thence S. 55-05 E. 140 feet to an iron pin; thence S. 34-55 W. 60 feet to an iron pin; thence N. 55-05 W. 140 feet to an iron pin, the point of beginning.

BEING the same property conveyed to the grantors herein by P. L. Bruce, Nora B. Bruce and Thomas S. Bruce by deed dated June 1, 1951, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Vol. 440, at page 136.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors, Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's (s') Heirs and Assigns against the grantor(s) and the grantor's (s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
