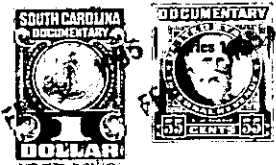

All those certain pieces, parcels or lots of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as lots Nos. 11 and 12, as shown on plat of Brookwood, recorded in the R.M.C. Office for Greenville County in Plat Book BB at Page 27, and being more particularly described as follows:

BEGINNING at an iron pin in the Northern side of Cambridge Drive, joint front corner of lots 10 and 11, and running thence with joint line of said lots, N. 5-48 W. 113.4 feet to corner of property now or formerly of O. Jones; thence with the line of said property, N. 12-02 W. 53.7 feet to an iron pin, rear corner of lot 51; thence with the rear line of lots 51 and 50, N. 87-45 W. 195.7 feet to an iron pin, corner of lot 13; thence with line of said lot, S. 2-15 W. 165 feet to an iron pin in the Northern side of Cambridge Drive; thence with said Drive, S. 87-45 E. 200 feet to the point of beginning.
