

BEGINNING at an iron pin on Charles Drive at joint front corners of Lots No. 157 and 158 and running thence along the line of said Lot No. 157, S. 89-31 E. 150 feet to iron pin at rear line of Lot No. 170; thence with the rear line of said Lot No. 170, N. 0-29 E. 60 feet to iron pin to iron pin at back corner of Lot No. 159; thence along the line of said Lot No. 159, N. 89-31 W. 150 feet to iron pin on Charles Drive; thence running with the said Charles Drive S. 0-29 W. 60 feet to iron pin at point of beginning.
