Nabors (formerly Pearl Ross) in the State aforesaid, in consideration of the sum of Nine Thousand Four Hundred Thirty-seven and 75/100---DOLLARS, (\$9,437.75) and assumption of mortgage to Pilot Life Insurance Co. of \$13,562.25, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William W. Smith and Mary E. Smith the following described property, to-wit:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being on the southern side of Hillcrest Drive, and being known and designated as Lot No. 6 of Section "B" according to plat of Highland Terrace, made October, 1936, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book D, Page 238, and having the following metes and bounds, to-wit:

BEGINNING At an iron pin on the south side of Hillcrest Drive, joint northern corner of lots Nos. 6 and 7, which iron pin, with the curvature of Wautauga Street and Hillcrest Drive, is approximately 188.38 feet west of the intersection of Hillcrest Drive and Wautauga Street; and running thence along Hillcrest Drive N. 67-03 W. 75 feet to an iron pin, joint northern corner of Lots Nos. 5 and 6; thence along the joint line of said lots, S. 23-30 W. 190 feet to an iron pin on a 10-foot alley; joint southern corner of Lots 5 and 6; thence along the line of said 10-foot alley, S. 67-03 E. 75 feet to an iron pin, joint southern corner of lots 6 and 7; thence along the joint line of said lots 6 and 7, N. 23-30 E. 190 feet to the beginning corner.
