## CHARTER BY THE SECRETARY OF STATE

WHEREAS,

J. M. PERRY AND L. P. GILLIAM

both of Greenville, S. C.

, 19 55 , file with the Secretary of State a written Declaration,

signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is

SELIGMAN & LATZ OF GREENVILLE, INC.

THIRD: That the principal place of business is

GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is

To buy, sell, lease and operate beauty parlors, beauty salons, hairdressing and manicuring establishments, and beauty parlor, beauty salon, hairdressing and maincuring concessions and departments in department stores and 'ladies' wear specialty shops.

To manufacture, buy, sell, import, export, distribute and generally deal in cosmetics, soaps, face powders and lotions, toilet creams, hair dyes, nail polishes, toilet supplies and all preparations, in the operation of or in connection with beauty parlors, hairdressing and manicuring establishments.

FIFTH: That the amount of the capital stock is Six Hundred (\$600.00) - - - - - Dollars ayable in money, or in labor or in property at its par value, when and as required by the board of directors.

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bono fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont

a newspaper published in the County of

Greenville

NOW, THEREFORE, I, O.
