All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, near Cross Roads Baptist Church, .lying on the western side of the road that leads, from Cross Roads Baptist Church to Pelham (formerly known as the Ridge Road), being bounded on the western and northern sides by other lands of myself, on the eastern side by the said road and on the southern side by lands of J. E. McCall, and being a part of the same land that was conveyed to me by deed from W. L. Ford April 23rd 1940, recorded in the office of the R. M. C. for Greenville County in Deed Book 224 at page 362, and having the following courses and distances, to wit:-

McCall land, and runs thence with the said road, N.54-30 W. 200 feet to a slight bend; thence N. 58-45 W. 45 feet to a nail and stopper in the said road; thence S. 54-00 W. 33 feet to an iron pin on the bank of the road, then continueing with the same course for a total distance of 363 feet to an iron pin, new corner; thence S. 54-24 E. 243.6 feet to an iron pin on the McCall line; thence with the said line N. 54-00 E. 367 feet to the beginning corner (there is also an iron pin back on line at 32 feet), containing Two and No/100 acres, more or less.
