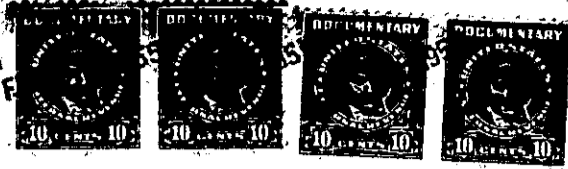

Caldwell according to survey and plat by H.L. Dunahoo, Surveyor, dated October 24, 1949, and recorded in Plat Book "X", page 1, R.M.C. Office for Greenville County, having a width of 70 feet and a depth of 176 feet.
