KING AND J. G. CELY, THEIR HEIRS AND ASSIGNS,

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 11 as shown on Plat of "Pine Brook Development" made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book "Z", at page 148, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Elaine Drive joint front corner of Lots 11 and 13 and running thence along common line of said Lots N. 56-29 E. 150 feet to an iron pin joint rear corner of said Lots; thence S. 33-31 E. 82.5 feet to an iron pin joint rear corner of Lots 9 and 11; thence along the common line of said Lots S. 53-37 W. 150 feet to an iron pin on Elaine Drive; thence along Elaine Drive N. 33-31 W. 90 feet to the point of beginning.

This conveyance is made subject to the Restrictive and Protective Covenants applicable to Pine Brook and recorded in the R. M. C. Office for Greenville County, South Carolina, in Book of Deeds 443, at page 307, and Book of Deeds 462, at page 33.
