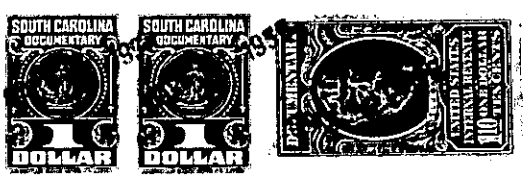

Strickland in the State aforesaid, in consideration of the sum of FIVE HUNDRED FIFTY AND NO/100 (\$550.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. STRICKLAND, his heirs and assigns, forever:

All that lot of land in Greenville County, South Carolina near Welcome Road known and designated as Lot No. 9 on Strickland Drive as shown by plat of property of J. E. Strickland made by J. C. Hill, August 6, 1954, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the joint corner of Lots Nos. 8 and 9 on the Eastern side of a 30 foot road, which pin is 140 feet from the Southern property line of said subdivision measuring along the Eastern side of said 30 foot road, and running thence with said road N. 17 E., 70 feet to a pin at corner of Lot No. 10; thence with line of Lot No. 10, S. 73 E., 171 feet to a pin on line of Hammond property; thence with line of Hammond property S. 17 W., 70 feet to pin at rear corner of Lot No. 8; thence with line of Lot No. 8, N. 73 W., 171 feet to the beginning corner.
