Ponder, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Marion C. Ponder, Jr., and Harriett M. Ponder and their heirs and assigns:

All that certain parcel or lot of land situated on the west side of Woodland Drive, near the limits of the City of Greer and northward therefrom, in Chick Springs Township, Greenville County, State of South Carolina, being designated as Lot No. 15 of a subdivision known as "Pinebrook" according to survey and plat by H.S. Brockman, Registered Surveyor, dated February 21, 1955, to be recorded, and having the following courses and distances, to wit: Beginning at a stake on the west side of Woodland Drive, corner of Lots Nos. 14 and 15, and running thence along the line of the same, S. 82.00 W. 203 feet to a stake on the brook; thence up said brook as a line, S. 23.48 E. 103.4 feet to a stake, corner of Lot No. 16; thence along the line of Lot No. 16, N. 79.30 E. 175 feet to a stake on the west side of Woodland Drive; thence along the west side of said Drive, N. 8.00 W. 92 feet to the beginning corner.

This property is conveyed subject to the Restrictions and Protective Covenants placed on this subdivision by the grantors herein of even date herewith, and to be recorded.
