to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Kelley C. Scott, his heirs and assigns forever.

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 32 of a subdivision known as Chestnut Hills as shown on a plat thereof recorded in the R. M. C. office for Greenville County in Plat Book GG, at page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Farmington Road, joint front corner of Lots 31 and 32, and running thence with the joint line of said lots, N. 66-23 E. 226.4 feet to an iron pin at the rear corner of Lot No. 41; thence with the rear lines of Lots 41 and 40, N. 60-12 W. 145.4 feet to an iron pin, joint rear corner of Lots 32 and 33; thence with the joint line of said lots, S. 46-55 W. 150.4 feet to an iron pin on the northeastern side of Farmington Road; thence with said road, S. 30-53 E. 65 feet to the beginning corner; being one of the lots conveyed to me by Chestnut Hills, Inc. by deed dated January 31, 1955 and recorded in the R. M. C. office for Greenville County in Vol. 518, at page 197.

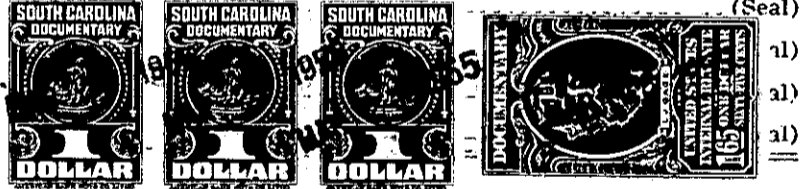
