All that lot of land in Greenville County, State of South Carolina, in Greenville Township, on the Northern side of Ashley Avenue, being shown as lot No. 2 on the revised plat of W. L. Cassaway recorded in the R.M.C. Office for Greenville County in Plat Book I at Page 80, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the Northern side of Ashley Avenue, at the joint corner of lots Nos. 2 and 3, and running thence with the line of lot 3, N. 24-38E. 151.6 feet to iron pin; thence N. 72-20 W. 63.3 feet to iron pin, corner of lot # 1; thence with line of lot # 1, S. 24-38 W. 144 feet to iron pin on Ashley Avenue; thence with the Northern side of Ashley Avenue, S. 65-30 E. 63 feet to the point of beginning.
