That We, L. A. Moseley and John T. Douglas, in the State aforesaid, in consideration of the sum of One Thousand Nine Hundred Ninety Five & NO/100 (\$1,995.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William E. Looper, Jr., his heirs and assigns forever

All that piece, parcel or lot of land, situate, lying and being on the western side of Forest Green Road in the County of Greenville, State of South Carolina, and known and designated as Lot No. 235 on plat of Sherwood Forest, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "GG", Pages 2 & 3, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Forest Green Road, which iron pin in the joint front corner of Lots Nos. 235 and 236; running thence along the joint line of said lots, N. 73-53 W. 155.6 feet to an iron pin; thence S. 26-31 W. 85 feet to an iron pin at the joint rear corner of Lots Nos. 235 and 234; thence along the joint line of said lots, S. 76-44 E. 175 feet to an iron pin on the western side of Forest Green Road; thence along the western side of Forest Green Road, N. 13-16 E. 75 feet to an iron pin, point of beginning.

Forest Green Road referred to above is now known as Scarlett Street.
