All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina situate, lying and being near Mills Mill and being known and designated as Lot No. 14 of Sunnymede as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "II", page 109 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Chestnut Street, joint front corner of Lots Nos. 13 and 14 and running thence with the line of Lot No. 14 S. 17-13 W. 243.2 feet to a point in the center of Brushy Creek; thence along the center of Brushy Creek as the line (the chord of which is S. 73-25 E. 68.8 feet) to the joint rear corner of Lots Nos. 14 and 15; thence along the line of Lot No. 15 N. 15-24 E. 240.7 feet to an iron pin on the southern side of Chestnut Street, joint front corner of Lots Nos. 14 and 15; thence along the southern side of Chestnut Street N. 71-30 W. 61.1 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

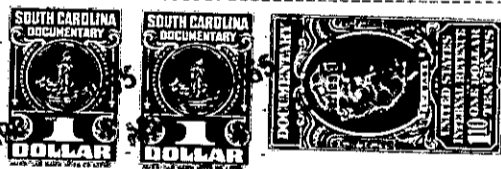
