

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, on the east side of West Belle Meade Boulevard, being shown and designated as Lot No. 109 on plat of Belle Meade prepared by Piedmont Engineering Service June 1954, and recorded in the R. M. C. Office for Greenville County in Plat Book GG at Page 67, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of West Belle Meade Boulevard at the joint corner of Lots Nos. 108 and 109, and running thence along the line of Lot No. 108, N. 83-16 E. 168 feet to an iron pin; thence N. 11-49 W. 80.3 feet to an iron pin at the rear corner of Lots Nos. 109 and 110; thence along the line of Lot No. 109, S. 83-16 W. 160.9 feet to an iron pin on the east side of West Belle Meade Boulevard; thence along the east side of West Belle Meade Boulevard, S. 6-44 E. 80 feet to the beginning corner, and being the same conveyed to me by Derby Heights, Inc. by deed dated August 17, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 506 at Page 287.
