ALL that lot of land situate, lying and being on the West side of Scarlett Street (formerly known as Forest Green Road), near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 218 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", pages 2 and 3 (also recorded in Plat Book "GG", pages 70 and 71) and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Scarlett Street at joint front corner of lots 217 and 218 and running thence with the line of lot 217 S. 83-02 W. 170 feet to an iron pin; thence N. 6-58 W. 75 feet to an iron pin; thence with the line of lot 219 N. 83-02 E. 170 feet to an iron pin on the West side of Scarlett Street; thence with the West side of Scarlett Street S. 6-58 E. 75 feet to the beginning corner.
