to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. H. BOONE AND ANNIE MAE F. BOONE, their heirs and assigns, forever:

ALL that lot of land situate on the Northwest side of Darlington Avenue, near the City of Greenville, in Greenville County, S. C., being shown as Lot 8 on plat of property of O. O. Freeman, made by Dalton & Neves, Engineers, October, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "X", page 78, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Darlington Avenue at corner of other property of Grantor and running thence with the line of other property of the Grantor, N. 26-35 W. 120 feet to an iron pin; thence N. 64-56 E. 75 feet to an iron pin; thence S. 38-29 E. 120 feet to an iron pin on the Northwest side of Darlington Avenue; thence with the Northwest side of Darlington Avenue S. 63-05 W. 100 feet to the beginning corner.
