William W. Pulliam, his heirs and assigns forever:

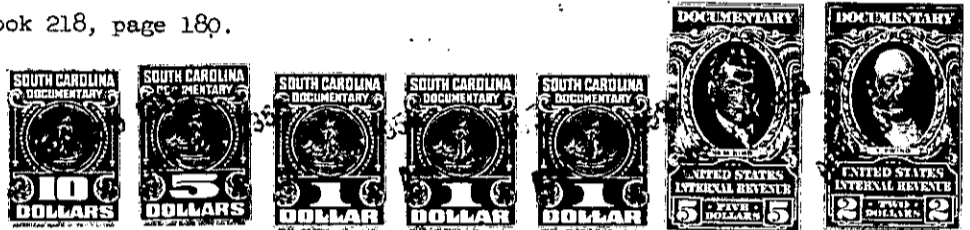
All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Northerly side of East Welborn Street, near the City of Greenville, S. C., being shown as Lot No. 48 on the plat of Anderson Street Highlands as recorded in the RMC Office for Greenville County, S. C. in Plat Book "J", page 157, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of East Welborn Street, which pin is 100 feet Northwest of the Northerly corner of the intersection of East Welborn Street and Hodges Street and is the joint front corner of Lots Nos. 47 and 48, and running thence along the joint line of said Lots N 42-40 E 150 feet to an iron pin; thence N 47-20 W 50 feet to an iron pin, joint rear corner of Lots Nos. 48 and 49; thence along the joint line of Lots Nos. 48 and 49 S 42-40 W 150 feet to an iron pin on the Northeasterly side of East Welborn Street; thence along the Northeasterly side of said Street S 47-20 E 50 feet to the point of beginning.

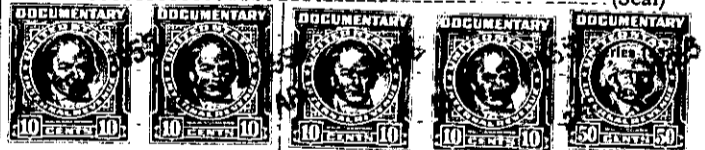
