Hightower and Margie M. Hightower, their Heirs and Assigns, forever:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Eastern side of Elizabeth Drive and being known and designated as Lot No. 222 on Plat of property of Robert J. Edwards recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book EE, at page 61, and having, according to said Plat, the following metes and bounds, to-wit:
