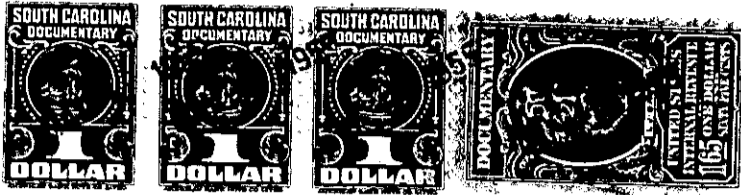

KNOW ALL MEN BY THESE PRESENTS, That WE, A. V. TRIBBLE and  
MADGE L. TRIBBLE,

to us in hand paid at and before the sealing of these presents  
by R. A. JOHNSON,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. A. JOHNSON, his heirs and assigns forever:

ALL that lot of land situate on the South side of Horseshoe Circle, about eight (8) miles south of the City of Greenville, in Greenville County, S. C., lying west of the Fork Shoals Road, and being shown as Lot 9 on plat of Donaldson Heights made by C. C. Jones, Engineer, in February 1955, said plat being recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "EE", at Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Horseshoe Circle at joint front corner of Lots 8 and 9 and running thence with the line of Lot 8, S. 27-47 E., 136 feet to an iron pin; thence S. 65-13 W., 92 feet to an iron pin on the East side of Horseshoe Circle; thence with the East side of Horseshoe Circle, N. 24-47 W., 110 feet to an iron pin; thence with the curve of Horseshoe Circle (the chord being N. 18-43 E., 29 feet) to an iron pin; thence still with Horseshoe Circle, N. 62-13 E., 65 feet to the Beginning corner.

ALSO, all that lot of land situate on the North side of Horseshoe Circle, about eight (8) miles South of the City of Greenville, in Greenville County, S. C., lying West of the Fork Shoals Road, and being shown as Lot 10 on plat of Donaldson Heights made by C. C. Jones, Engineer, in February 1955, said plat being recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "EE", at Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Horseshoe Circle at joint front corner of Lots 10 and 11 and running thence with the line of Lot 11, N. 24-47 W., 130 feet to an iron pin; thence S. 65-13 W., 85 feet to an iron pin on the East side of Horseshoe Circle; thence with the East side of Horseshoe Circle, S. 24-47 E., 110 feet to an iron pin; thence with the curve of Horseshoe Circle (the chord being S. 69-47 E., 28.3 feet) to an iron pin; thence continuing with Horseshoe Circle, N. 65-13 E., 65 feet to the Beginning corner.
