All that piece, parcel or lot of land in Greenville Township, Granville County, State of South Carolina, on the Southeastern side of J. S. Super mighway 20, 20, sla known as Wade Hampton Boulevard being known and designated as the property of J. T. Welton Company, Inc. according to a plat of C. C. Jones, Engineer, dated October, 1961, and recorded in the R.M.C. Office for Greenville County in Plat Book A, page 192, and having according to said plat the following meter and bounds, to-wir:

BEGINNING at an iron pin on the Southeastern side of U. S. Super Highway No. 20 of the corner of property now or formerly of Bosson and running thence cloud line of a s Benson property S. 37-30 E. 300 feet to an iron pin; thence S. 52-30 ... 100 foot to a iron min; thence along the line of property now or formerly owned by Gouch, N. 37-30 ... 275 fest to an iron pin; thence N. 52-30 E. 35 feet to an iron pin; thence N. 27-30 W. 25 feet to an iron pin; thence along the right of way of Himmer No. 29, No. 2-30 E. 35 feet to the point of beginning.
