All that lot of land in Greenville Township, Greenville County, state of South Carolina, being known and designated as the northern portion of Lot No. 46 on Map No. 2 of Camilla Park, made by W. J. Riddle, Surveyor, December, 1943, recorded in plat book M. page 85 of the R. M. C. Office for Greenville County and being more particularly described as follows:

Beginning at an iron pin on the western side of Flora Avenue, the front joint corner of lots Nos. 46 and 47 and running thence with the joint line of said lots N. 80-44 W. 200 feet to an iron pin the rear corner of lot No. 23; thence with the rear line of said lot S. 9-16 W. 26 2/3 feet to an iron pin, corner of property of the grantee; thence with the line of said property S. 80-44 E. 200 feet to an iron pin on the western side of Flora Avenue; thence with the west side of said Avenue N. 9-16 E. 26 2/3 feet to the beginning corner.
