KNOW ALL MEN BY THESE PRESENTS, That I, L. A. MOSELEY

in the State aforesaid, in consideration of the sum of One Dollar and Division of
Property Dollars

to me in hand paid at and before the sealing of these presents
by JOHN T. DOUGLAS

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOHN T. DOUGLAS, his heirs and assigns, forever:

ALL my undivided one-half ($\frac{1}{2}$) interest in and to those lots of land located in the City of Greenville and just outside the corporate limits of the City of Greenville, in Greenville County, South Carolina, in the subdivision known as Sherwood Forest, being shown on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", pages 70 and 71, said lots being specifically shown on said plat as follows:

Lots 61 and 62, fronting along Friartuck Road;
Lots 69, 78, 79, 80, 81, and 84 fronting on Don Drive;

Also, all that parcel of land being shown as the Northeast portion of Lot 85 on plat of Sherwood Forest referred to above, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Don Drive at joint front corner of Lots 84 and 85, and running thence with the line of Lot 84, S. 32-19 E., 167 feet to an iron pin; thence S. 60-01 W., 20 feet to an iron pin; thence running through Lot 85, N. 45-53 W., 170.6 feet to an iron pin on the Southeast side of Don Drive in the front line of Lot 85; thence with the Southeast side of Don Drive, N. 57-41 E., 60 feet to the beginning corner.

Lot 88 fronting on Sir Abbot Street;
Lots 129, 130, 131, and 132, fronting on Parkins Mill Road;
Lots 140 and 173, fronting on Lady Marion Lane;
Lots 152, 258, and 259, fronting on Robin Hood Road;
Lots 188 and 204, fronting on Nottingham Road;
Lots 217, 217 A, 214, 215, 225, 226, 228, 230, 236, 247, and 253, fronting on Scarlett Street (formerly known as Forest Green Road.)
