TRAXLER in the State aforesaid, in consideration of the sum of Six Thousand One Hundred and No/100- - - - - DOLLARS, and assumption of mortgage described below: to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ALBERT ROY ASHLEY, JR., his heirs and assigns:

All those pieces, parcels or lots of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 65 and 66, Pleasant Valley Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "B", page 163, and being, according to said plat, the following rates and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Prince Avenue, joint front corner Lots 66 and 67, being 244.1 feet in a Northwesterly direction from the intersection of Prince Avenue and Pleasant Ridge Avenue, and running thence S. 69-31 W. 175 feet to an iron pin, joint rear corner Lots 66 and 67; thence N. 20-29 W. 120 feet to an iron pin, joint rear corner Lots 64 and 65; thence N. 69-31 E. 175 feet to an iron pin on the Southwesterly side of Prince Avenue, joint front corner Lots 64 and 65; thence along the Southwesterly side of Prince Avenue, S. 20-29 W. 120 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to The First National Bank, an Executor, on which there is a balance due of \$2,000.00; said mortgage is recorded in Mortgages Volume 221, page 412.
