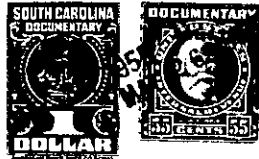

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Doyle E. Burgess, his heirs and assigns forever,

All that lot of land in the State and County aforesaid, being known and designated as Lot No. 42 on plat of Wynette Estates by Pickell & Pickell, Engineers, dated July 24, 1953, recorded in the RMC Office in Greenville County in Plat Book EE, at page 37 and having, according to said plat, the following courses and distances, to wit:

BEGINNING at an iron pin at the northwestern intersection of Willimon Drive and Wyoming Avenue and running thence along the northern side of Willimon Drive N 89-04 W 200 feet to an iron pin; thence along the rear line of Lot No. 21, N 5-46 E 80 feet to an iron pin, joint rear corner of Lot Nos. 41 and 42; thence along the joint line of said lots, S 89-04 E 200 feet to an iron pin on the western side of Wyoming Avenue; thence with Wyoming Avenue S 5-46 W 80 feet to the beginning corner.

This property is subject to restrictions, covenants and conditions as recorded in the RMC Office in Volume 495, at page 523, and on the aforementioned plat.
