KNOW ALL MEN BY THESE PRESENTS, That we, Mary A. Metts, Frances A. Gunn, James S. Adams, Edward D. Adams, George A. Adams, Preston W. Adams, Louise A. Johnson, Sara A. Sloan, William Edward Adams, Elsie A. Elliott, Clarence Adams, Elizabeth A. Dindlebeck, Robert Adams, and John P. Adams in consideration of the sum of One and No/100 Dollars to us in hand paid at and before the sealing of these presents by John P. Mann, as Trustee, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John P. Mann, as Trustee, his successors and assigns forever:

All that piece, parcel or tract of land in the County of Greenville, State of South Carolina, situate and being on the western side of U. S. Highway No. 25, and containing 10 1/2 acres, more or less, according to a plat of the property of W. C. Adams made by W. J. Riddle, Surveyor, March, 1948, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the western side of U. S. Highway No. 25, and running thence S. 85-10 W. 1017 feet to an iron pin; thence N. 9-50 W. 386 feet to a pin in a branch; thence up the branch and along the meanders thereof the following courses and distances, N. 78-30 E. 210 feet; N. 85-30 E. 71.5 feet; N. 75-00 E. 204 feet; N. 66-40 E. 205 feet; S. 78-30 E. 162 feet; N. 72-00 E. 178.5 feet to a stake on the western side of U.
