


Beginning at an iron pin on the northeastern side of Myron Lan, the front joint corner of Lots 4 and 5; thence with the joint line of said lots 11.3C-01 1.152.4 feet to an iron pin; thence S. 75-43 11.100.8 feet to an iron pin, the rear corner of Lot No. 1; thence with the rear line of Lots 1, 2 and 3, 1.39-35 11.190.55 feet to an iron pin on the northeastern side of Myron Lane; thence with the curve of said street the chord of which is N. 51-0 11.53.4 feet to a point; thence continuing with the northeastern side of said Street 11.59-59 11.12.7 feat to the beginning corner.
