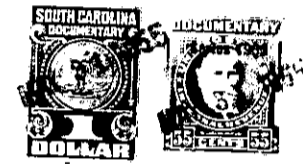
Know All Men by These Presents:

Mackey and Emma P. Mackey, their heirs and assigns forever:

All that lot of land in the County of Greenville, State of South Carolina being known as lot no. 8 of the plat of Forest View made by T. C. Adams dated February 1955 and recorded in the R.M.C. Office for Greenville County in Plat Book II at Page 105 and having, according to said plat, the following metes and bounds to-wit:

Beginning at an iron pin on the northern side of Gilstrap Drive, at the joint front corner of lots nos. 7 and 8 and running thence along the line of lot no. 7, N 10-39 W, 177.6 feet to an iron pin, rear corner of lot no. 7; thence along the line of lot no. 5, N 84-29 E, 80 feet to an iron pin, rear corner of lot no. 9; thence along the line of lot no. 9, S 10-16 E, 134.2 feet to an iron pin on the northern side of Gilstrap Drive; thence with said Drive, S 39-14 W, 80 feet to the point of beginning, being the same property conveyed to the grantors by Deed Book 522 at Page 405.
