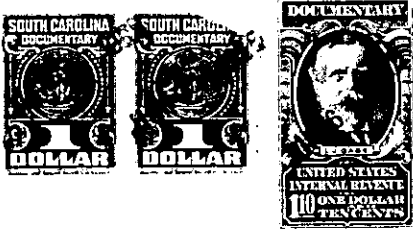
Know All Men by These Presents:

All that piece, parcel or lbt of land in Grove Township, Greenville County, S. C. on a new cut street off Old Grove Road, and designated as lot number 7, according to plat of property of Pauline O. Mahaffey revised by J. C. Hill, L. S. March 30, 1955 and recorded in plat book "DD" at page 168, R. M. C. Office for Greenville County, S. C., and being more particularly described as follows:

BEGINNING at an iron pin on the north side of said new cut street and being 350 feet east from Old Grove Road at the joint front corners of lots numbers 6 and 7, thence along the line of lot number 6, north 35-24 E. 200 feet to an iron pin; thence E. 44-30 W. 100 feet to an iron pin; joint corners of lots numbers 7 and 8; thence along the line of lot number 8 S. 35-24 W. 200 feet to an iron pin on new cut street; thence along the north side of new cut street N. 44-30 W. 100 feet to the beginning corner, and being all of lot number 7, according to said plat.
