All of that parcel or tract of land in Saluda Township of Greenville County, South Carolina, on the North Fork of Saluda River and West from U.S. Highway No. 25, having the following courses and distances: BEGINNING at a stone lower edge of Duff Rock, corner with property now or formerly owned by John Poole, and runs thence with the Poole line N. 85, 15 F. 1683 feet to a poplar on a branch; thence with the branch across road, thence with Saluda River in a southerly direction 712 feet to the old Ballenger line; thence with the old Ballenger line S. 61.15 E. 3031 feet to a stone; thence S. 14 W. 630 feet; thence S. 43.30 W. 395 feet to line of tract No. 2 on plat hereafter mentioned; thence with line of tract No. 2 N. 61 W. 3061 feet to point in center of old bridge across Saluda River; thence N. 65.30 W. 535 feet to center of river road; thence with said road S. 24.45 W. 141 feet to an iron pin at intersection of branch with road; thence with the branch N. 9.45 W. 170 feet; thence N.35.30 W. 1050 feet to stone on lower edge of Duff Rock; thence N. 14 E. 1010 feet to the beginning corner, being all of Tract No. 1 as shown on a plat of property made for the estate of John H.
