to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ALBERT L. SMITH, His Heirs And Assigns,

ALL that certain, piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 27 of Block "B", Mayfair Estates, as shown on plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "S", at Pages 72 and 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Tipperary Lane, joint front corner of Lots 26 and 27, and running thence along the common line of said lots, S.60-48 E. 150 feet to an iron pin, joint rear corner of Lots 10 and 27; thence along the common rear line of said lots, N.29-12 E. 50 feet to an iron pin; thence along line of lot 28, N.60-48 W. 150 feet to an iron pin on Tipperary Lane; thence along Tipperary Lane, S.29-12 E. 50 feet to the point of beginning.

This deed is made subject to the restrictions applicable to Mayfair Estates and recorded in the R.M.C. Office for Greenville County, South Carolina, in deed book 344, at Page 261. This deed is further subject to utility easements of record.
