G. Pace, his heirs and assigns

All that piece, parcel and lot of land lying and being in Gantt Township, County of Greenville, State of South Carolina, near the city of Greenville, lying and being in that certain subdivision known as "Belle Meade", being owned by Derby Heights Inc. shown as Lot No. 27 according to a plat made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "EE" at Pages 116 and 117, being more particularly described as follows:

BEGINNING at an iron pin on the west side of Brookforest Drive at the joint front corner of Lots 27 and 28 and running along the joint line of Lots 27 and 28 S. 69-44 W. 148.6 feet to an iron pin, the joint rear corner of Lots 27 and 28; thence with the joint line of Lots 26 and 27 N. 27-20 W. 87.7 feet to an iron pin on Camden Lane; thence with Camden Lane N. 51-17 E. 75 feet; thence continuing with Camden Lane N. 55-24 E. 53 feet; thence along the curve of Camden Lane and Brookforest Drive S. 77-30 E. 43.7 feet; thence along the Brookforest Drive S. 20-16 E. 100 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, as amended in Deed Book 511, at Page 513, as further amended in Deed Book 521 at Page 199.
