All that piece, parcel or lot of land situate, lying and being in and near the City of Greenville, in Greenville County, State of South Carolina and being known and designated as Lot No. 27, Section H of Croftstone Acres according to a revised plat of a portion of Croftstone Acres prepared by Piedmont Engineering Service, August 8, 1950 and recorded in the R. M. C. Office for Greenville County in Plat Book "Y", at Page 91 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Broughton Drive, joint front corner of Lots Nos. 26 and 27 and running thence along the joint side line of said lots N. 17-35 W. 201.9 feet to an iron pin, joint rear corner of said lots; thence N. 72-49 E. 70 feet to an iron pin, joint rear corner of Lots Nos. 27 and 28; thence along the joint side line of said lots S. 17-35 E. 201.4 feet to an iron pin, joint front corner of said lots; thence along the northern side of Broughton Drive S. 72-25 W. 70 feet to the point of beginning.
