in the State aforesaid, DOLLARS,

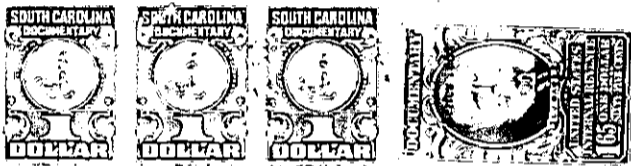

Troy A. Barton and Joyce F. Barton, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the Westerly side of Woodberry Way, near the City of Greenville, S. C., being shown as Lot No. 19 on the plat of Hollyvale as recorded in the R.C. Office for Greenville County, S. C. in Plat Book "Y", page 131, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Woodberry Way at a point 105 feet South of the Westerly corner of the intersection of Woodberry Way and Timber Lane, said pin being the joint front corner of Lots Nos. 19 and 20, and running thence along the joint line of said Lots N 67-44 W 245.4 feet to an iron pin, joint rear corner of said Lots; thence along the creek as the line, a traverse line being S 0-11 E 102.8 feet to an iron pin, joint rear corner of Lots Nos. 18 and 19; thence along the joint line of said Lots S 67-44 E 207.3 feet to an iron pin on the Westerly side of Woodberry Way; thence along the Westerly side of Woodberry Way N 22-16 E 95 feet to the point of beginning.

As a part of the consideration hereof this property is conveyed subject to the building restrictions applicable to Hollyvale as recorded in the R.C. Office for Greenville County in Deed Book 440, page 537.
